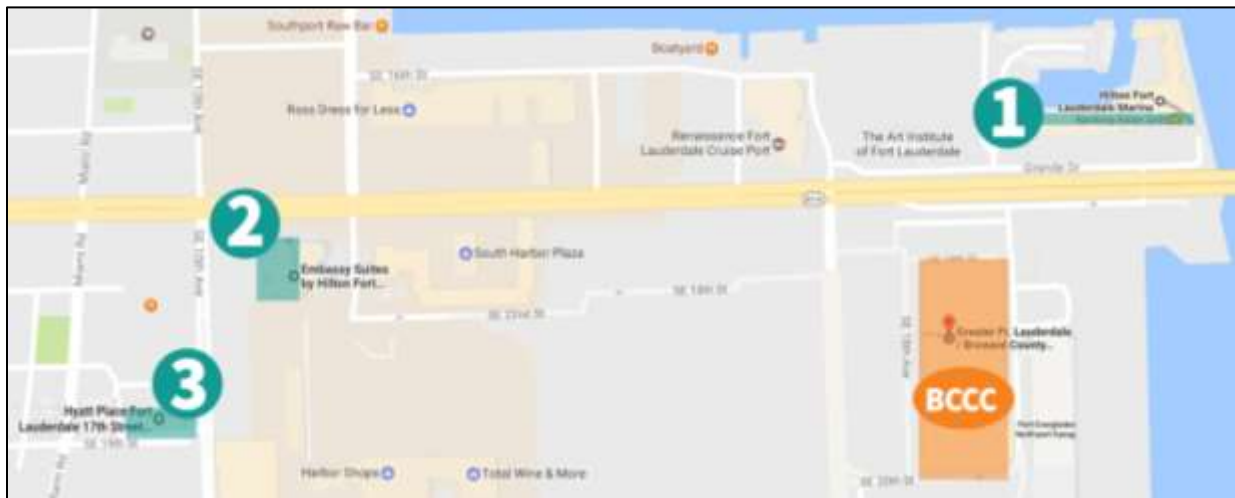

Exhibitor Parking

Exhibitor parking is \$15.00 per day in the Eisenhower parking lots located directly behind the Convention Center loading dock area.

Exhibitors who have a great deal of equipment should unload at the service road and park in the exhibitors' lot. Exhibitors who have a popup booth can unload from the exhibitor's lot and roll the equipment into the exhibit hall.
